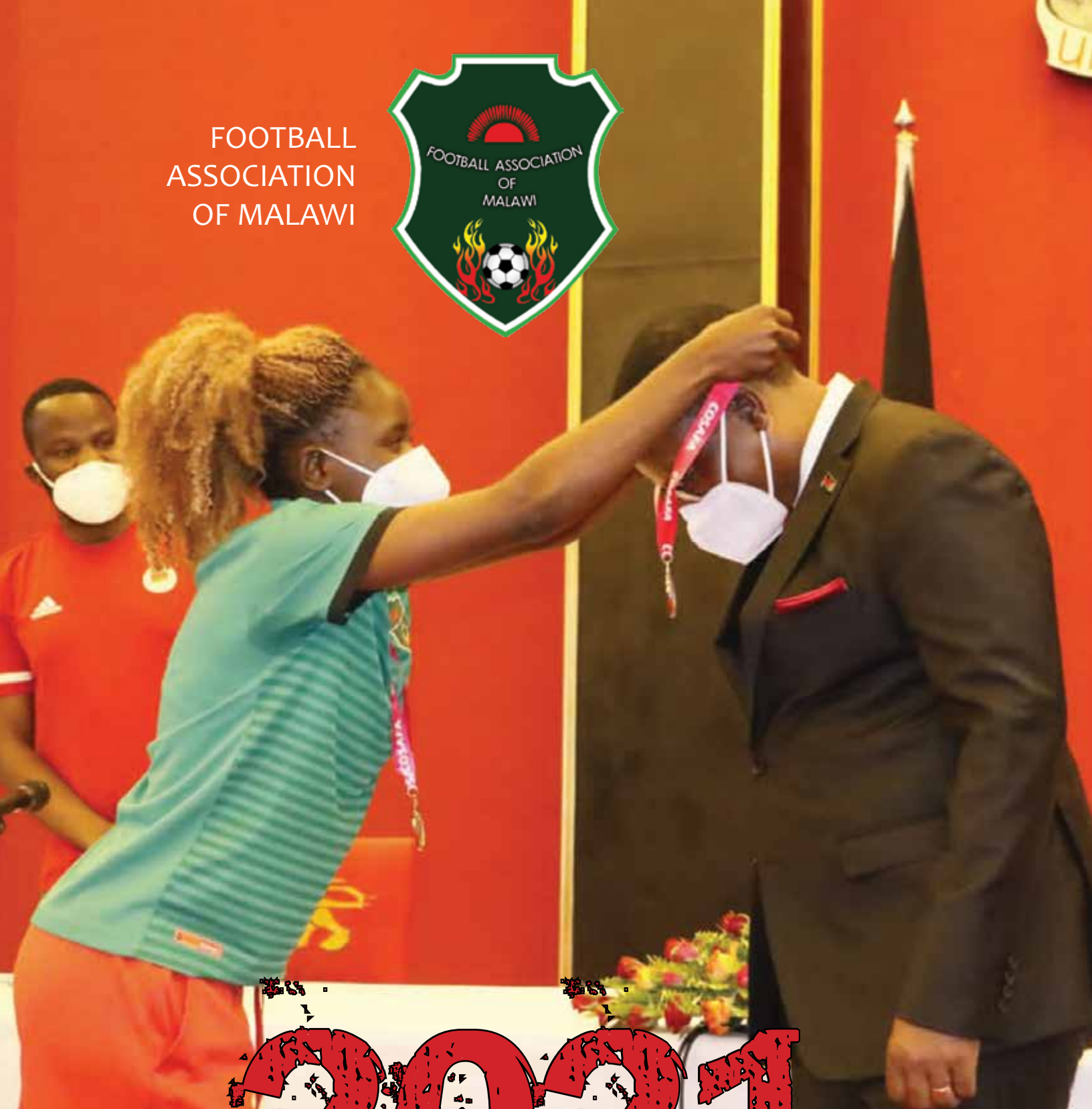

PRESIDENT'S STATEMENT

A SEMBLANCE OF NORMALITY RETURNS

When the Covid-19 pandemic struck, football took a back seat as the world came to terms with the unprecedented challenges we faced.

Countless events and opportunities fell by the wayside, causing competition organisers, clubs and players considerable uncertainty. FAM was not immune to the inevitable trend, with significant cancellations and postponements to both major and grassroots events the only option throughout the year.

Last year, FIFA acted quickly and decisively to allocate funding to all member associations and confederations through the FIFA Covid-19 Relief Plan.

To prepare a relief plan worth \$1.5 billion was truly unprecedented and historic in sport and is a testament to the unity of the football family in times of crisis.

We are proud to say that this funding heavily imparted on our players during the pandemic and helped mitigate the crisis. Additionally, we are proud to report that, having passed a strenuous audit process, it was noted that the funding reached and benefitted the intended beneficiaries.

Continuing into 2021, this funding has allowed for the restart of football across the country, testing of players, officials and supporters at all levels of the game and the enacting of safeguarding measures to ensure football stakeholders are protected in a time of crisis.

This is the year that we celebrated the return to international football following Flames' qualification to the AFCON tournament.

And even when the odds seemed stacked against us due to inadequate funding, with the generosity of all Malawians, the government, our sponsors and stakeholders, we made the dream come true and we were able to raise more money than ever before to enable the AFCON dream to come true.

One of our major achievements over the year was the launch of the FAM Under-14 League in August.

With this league, we want to lay a foundation for a strong team in the future and, as an association, we believe that this can only be possible if the boys start playing organised football at a very young age such as the Under-14 league.

We had an FCB Under-20 League, FAM Under-17 and Under-16 leagues and we just launched the FAM Under-23 districts leagues. The missing link was the Under-14 league.

We now have a complete path for players to play organised compete football from Under-14 to Under-23 and with that we should be able to retain and nurture all available talent for the Flames.

The Under-14 League was piloted in 14 districts but will expand to all the 34 educational districts by 2022.

The women's game also showed signs of recovery and great promise.

The Women's Senior Team, the Scorchers, arrived at the 2021 COSAFA Women's Competition in South Africa as underdogs but left the Rainbow Nation as heroes, having humbled perennial victors South Africa on the way to the finals.

Although the team finally fell at the hands of Tanzania in the finals, they can hold their heads high fully cognisant in the fact that this is a building block for bigger things to come.

With these victories in mind, the small baby steps that we have taken moving forward in the midst of a global pandemic, we can only look forward to tackling the future with much more courage and walk a little bit taller knowing for a fact that we hold the future in our hands.

With a little more effort, coordination and unity of purpose, we have seen what is possible. Let us unite, one again, in our quest to 'Raise the Flag.'



STATEMENT FROM THE GENERAL SECRETARY

THE LONG ROAD TO RECOVERY

The challenges that we faced in the last two years as a result of the Covid-19 pandemic has been well documented.

Covid-19 caused unprecedented hardship, heartache and harm in almost every walk of life. While FAM continued to recognise in its activities and initiatives that the battle persists, 2021 was the year when the world was able to take its first steps on the long road to healing hearts and minds – with the global game proving to be an important tool in that process.

FAM, in conjunction with the Ministry of Health, developed a blueprint to ensure the safe return of football. The Return to Football was the result of extensive consultation with different stakeholder representatives.

Additionally, the competition regulations for all football matches were adapted to reflect the new mandatory measures.

Despite the ravaging impact of the Covid-19 pandemic, 2021 was our most impactful year yet, thanks to the hard work and generosity of so many – staff, stakeholders, the Exco and our long time partners and collaborators.

But we have learnt to live with the pandemic, cautious of the fact that we still had to observe all preventive measures.

On the field, the Flames returned to action and although the team did not perform well during the COSAFA Cup and the World Cup qualifiers, going forward, we will continue to build on the positives to enable us to build a team for the future.

Apart from the Flames' qualification for the AFCON finals, the highlight from the past year was the National Women's team's heroic performance at the COSAFA Women's Championship where they emerged runners-up after falling short at the final hurdle.

Going forward, we will continue to support the team

and ensure that they have the resources to build on this performance and work towards winning the trophy.

At FAM, we also take great pride in Nyasa Big Bullets' CECAFA Club Championship participation where the team emerged runners-up, losing to Uganda Champions Express FC in the final.

FAM will continue to facilitate the participation of local teams in continental competition as this is definitely one way we can gauge the strength of our league and also expose our local players to international playing standards.

Coming to governance, FAM continues on its path of equipping key stakeholders with the requisite skills in line with the association's ideal of Raising the Bar. We believe that this ideal can only be realised if everyone involved in the management of the game is proficient and conversant with the role that they are tasked with.

For this reason, in realising that elections are a key component in governance, FAM continued to monitor the elective process of all Member Associations throughout the year. And we are proud to report here that the elections for the three regional committees – the South Region, Central Region and Northern Region football committees – were conducted without incident and in a fair and transparent manner.

This trend replicated itself during the elective process for the National Youth Football Association, the National Football Coaches Association and the Beach Association of Malawi.

Another major stride that we undertook in 2021 was the launch of the Under-14 leagues. This is a major landmark for the association as it will ensure that we are able to monitor our players from a young age.

A major activity worth celebrating was the launch of the District Leagues that aim to bridge the gap between lower leagues and the elite league as well as ensure synergy in football structures at all levels across the country.

FAM Covid-19 Taskforce meeting with BSA on football restart

Total football restart

Following an unprecedented year of disruption in 2020 due to the Covid-19 pandemic, football returned to full action at all levels in 2021.

FAM stopped all football activities on March 20, 2020, and by the end of that year only Super League and national teams had returned to action behind closed doors.

However, in 2021 FAM, through the Covid-19 Taskforce, came up with a plan of resuming football at all levels after the Malawi government had relaxed some Covid-19 regulations.

March 2021

In March, the FAM Taskforce met with Member Associations responsible for Regional, Women's Football and Youth Football competitions to plan on the resumption of their activities.

MAY

The three Regional Leagues' Premier Divisions kicked off in a changed format of playing in clusters to ensure they finish alongside the Super League.

The Three Regional Women's Leagues also kicked off on 29th May 2021.

The Task Force met Beach Soccer Association to plan on the resumption of Beach Soccer Zonal Leagues.

JULY

The FCB Under 20 League, Beach Soccer Zonal League and Districts Leagues kicked off.

Flames qualify for AFCON after 11 years

The Flames returned to African football's biggest stage when they qualified for the 2021 African Cup of Nations for the first time in 11 years.

The Meck Mwase side secured their qualification on March 29, 2021 after beating Uganda 1-0 at the Kamuzu Stadium in Blantyre courtesy of Richard Mbulu's 16th minute header.

The Flames finished second in their group with 10 points, two behind group winners Burkina Faso, to qualify for their third AFCON after 1984 and 2010 outings.

With the qualification, Mwase continued the legacy of local coaches who have guided the team to the continental finals. The two previous AFCON qualifications were achieved under local coaches; Henry Moyo in 1984 and Kinnah Phiri in 2010.

"I am happy to have achieved this feat; I owe it to the players, FAM and all stakeholders who gave us support. This is not about me but the boys, they worked hard and deserve it," said Mwase.

After the qualification, Mwase was given a new two-year contract until March 2023.

Flames lose to TZ in friendly

A month after qualifying for the AFCON, the Flames played their first game against Tanzania in an international friendly match in Dar es Salaam.

The Flames gave a debut to Scotland-based defender Kieran who plays for Scottish Premiership side Aberdeen.

However, with coach Meck Mwase and his assistant left behind in Malawi due to Covid-19, stand-in coach Bob Mpinganjira could only watch the team lose 2-0.

Flames at 2021 COSAFA Cup

In July, the Flames participated at the 21st Edition of the COSAFA Cup in Port Elizabeth, South Africa.

Mwase used the tournament to prepare for the 2022 FIFA World Cup group qualifiers which were due to start in September. He handled six players their debuts and these were Nyasa Big Bullets trio of goalkeeper Richard Chimbamba, defender Eric Kaonga,

winger Misheck Selemani and Silver Striker's trio of defenders Mark Fodya and Nickson Mwase and striker Maxwell Phodo.

He also recalled four veterans Zicco Mkanda, Muhammad Sulumba, Ndazona Chatsalira and Taonga Chimodzi who had been out of the team for some years.

However, the Flames bowed out of the group stages without a win after losing to Mozambique and Senegal as well as drawing with Namibia and Zimbabwe.

2022 FIFA World Cup Qualifiers

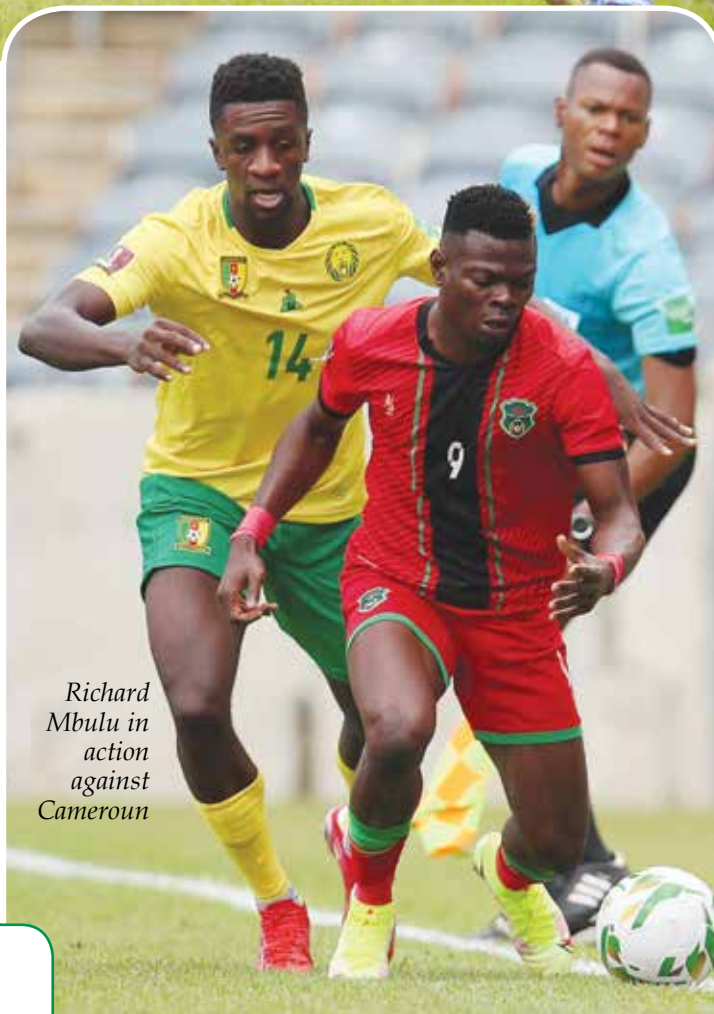
The Flames finally got into the 2022 World Cup group qualification campaign after almost a year as matches were put on hold due to Covid-19.

The Flames were in Group D alongside Ivory Coast, Cameroon and Mozambique.

The team was dealt a blow when Bingu National Stadium in Lilongwe and Kamuzu Stadium in Blantyre were banned by

CAF, hence the team was denied a home ground advantage. As a result of the ban, the Meck Mwase side used Orlando Stadium in Johannesburg, South Africa as their home ground.

After six matches, the team finished bottom of the group with just three points, having lost 2-0 and 4-0 to Cameroun, 3-0 and 2-1 to Ivory Coast and 0-1 to Mozambique. Their only win was 1-0 victory over Mozambique in Johannesburg.

AFCON Preparations

On December 22, 2021, Marınca named a 30-man provisional squad for a two-week camp in Jaddah, Saudi Arabia.

However, the camp was affected by Covid-19 as some players failed to travel while other spent more days in quarantine after testing positive to Covid-19.

While in Jeddah, the Flames played one friendly match against Comoros which they won 2-1 with goals from Gabadinho Mhango and Khuda Muyaba.

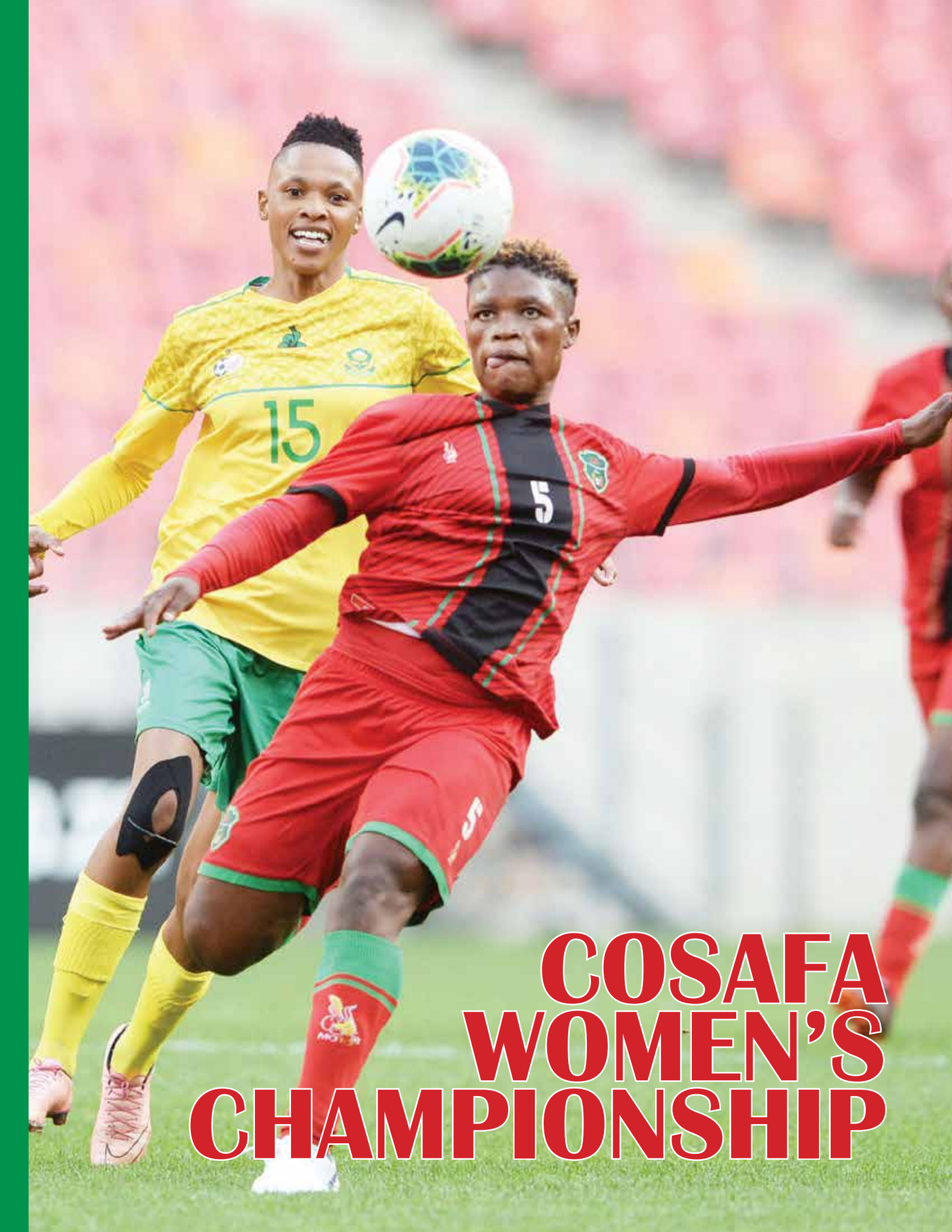

FAM Executive Committee KEY DECISIONS

The 10 members of the FAM Executive Committee met four times in 2021; in January, April, October and December and made a number of key decisions as follows:

January 9, 2021 (Sunbird Nkopola, Mangochi) **Football restarts for other leagues**

The committee resolved that the FAM Covid-19 Taskforce should engage Member Associations responsible for Regional Leagues, Youth Football, Women's Football and Beach Soccer to review the Football Restart Plan for the respective leagues.

The committee resolved to accept FISC Company Ltd's decision to pull out of sponsorship deal which expired on December 31, 2021 due to the company's current business operating environment.

In line with Article 75 of the FAM Statutes, the FAM Executive Committee decided to extend the mandate of three Regional Football Associations, which will expire in the next few days, until their cases with the Anti-Corruption Bureau (ACB) are concluded and elections can be properly conducted.

May 8, 2021 (Sigelege Beach Resort, Salima)

The committee approved the plan to officially roll out Mpira TV Channel when kicking-off the TNM Super League second round after a successful test run of the channel.

The meeting approved the recruitment of a Marketing Manager who would, among other key responsibilities, be dedicated to marketing and coordinating the operations of Mpira TV channel.

The committee rescinded its prior approval to hire a consultant to review the technical structure of Malawi Football. The committee approved the hiring of an experienced Technical Director to replace the current TD Captain John Kaputa (retired) who will retire at the end of his contract in June. This position will be open to both locals and internationals. The person identified as the TD will be responsible for both the technical review and implementation of Malawi Football.

The committee resolved to constitute an ad-hoc committee to champion thorough preparations and resource mobilization for the Flames AFCON 2021 Cameroon finals project. The preparations

project will involve high-level and wider participation of both the public and private sector. The ad-hoc committee will be headed by FAM First Vice President, Justice Jabbar Alide who is also the Chairperson of Competitions and Marketing Subcommittee.

The committee approved the hiring of an experienced Technical Director to replace the current TD Captain John Kaputa (retired) who will retire at the end of his contract in June.

The committee approved recommendations from Heads of Member Associations (MAs) to review their statutes to ensure that they align with FIFA, CAF and FAM statutes. The review of the statutes will among other things help to address existing administrative gaps and strengthen governance instruments.

December 3, 2021 (The Makokola Retreat, Mangochi)

The Executive Committee decided to re-organise the technical set-up of the Flames to ensure that it is well prepared for the forthcoming TotalEnergies Africa Cup of Nations to be played in Cameroun in January 2022. The Executive Committee approved that that new Technical Director Marian Mario Marinica should temporarily take charge of the Flames as Head of Technical Panel supported by coach Meck Mwase.

FAM Exco overturned the disciplinary committee's ruling in a case where former BSA Exco challenged the legitimacy of a newly-elected committee after FAM ordered fresh elections. In December 2020, FAM disci-

plinary committee ruled that FAM was wrong to direct BSA to hold fresh elections.

In its ruling the appeals committee faulted the disciplinary committee for exceeding its mandate of resolving the disciplinary issues placed before it by proceeding to make pronouncements on matters concerning the validity of elections conducted at the direction of FAM.

FAM challenges MAs to go digital

The Football Association of Malawi has challenged its Member Associations to embrace the use of technology in the management of the game.

FAM Second Vice President, who is also Finance and Administration Committee chairperson Othniel Hara, said this when he

presented laptops to the nine member associations in March 2021.

"These days, the use of computers is part of our daily lives. As football, we also need to move in that direction and use technology to manage the game. We noted that the Member Associations had challenges with equipment and, as a starting point, we thought of buying them laptops. We believe this

will help to ease their record management," said Hara.

Northern Region Football Association chairperson Lameck Khonje thanked FAM for the gesture, saying the association was facing problems managing data in the absence of computers.

The laptops are valued at K790,000 each, translating to a total of K7.1 million.

FAM Launches Under-14 Leagues

FAM says the only way to help realise the dream of grooming superstars is by putting in a pathway for defining player development.

Speaking at the launch of the FAM Under-14 League in Mulanje on August 13, 2021, Nyamilandu said: "We want to lay a foundation for a strong team in the future and, as an association, we believe that this can only be possible if the boys start playing organised football at a very young age such as the Under-14 league.

"We had an FCB Under-20 League, FAM Under-17

and Under-16 leagues and we just launched the FAM Under-23 districts leagues. The missing link was the Under-14 league.

"We now have a complete path for players to play organised compete football from Under-14 to Under-23 and with that we should be able to retain and nurture all available talent for the Flames.

The Under-14 League was piloted in 14 districts but will expand to all the 34 educational districts by 2022.

Each participating district received K1.5 million administration fund for the league and each team received three footballs from FAM.



FAM assembles first U14 National team

The Football Association of Malawi assembled a first ever Under 14 national team camp that was held in Blantyre from 14-18 December.

The camp brought together 30 players who were selected from the 2021 FIFA/FAM U-14 district leagues.

FAM Youth Development Officer James Sangala commended the boys for their performance during the five days, saying this is proof that Malawi has talent that needs to be nurtured through such kind of projects.

"In the five days that they were in camp, the boys were trained in all the basic football techniques like ball control, passing and heading and their response during training sessions proved that they are really the best of the best and we believe that this project will produce wonders in the next five to seven years if maintained," said Sangala.

FAM to make Luwingu main Youth Dev Centre

will rely on this facility.

"Once we set up the school of excellence it means that all the best players in Malawi will come from this academy. We want to have a proper catchment area to groom players to international standards," said Nyamilandu.

Once the wall is completed, the next phase will concentrate on constructing football pitches and school blocks and the academy is expected to be operational in three years' time.

FAM launches District Leagues

The Football Association of Malawi finally launched the district leagues across the country with the aim of bridging the gap between elite football and lower levels and ensure systematic football structures at all levels across the country.

FAM President Walter Nyamilandu Manda officially launched the leagues in the three regions starting with

Northern Region at Chiwaza ground in Chintcheche, Nkhata Bay on July 24, 2021, then central regional at Salima Community Centre ground on July 31 and finally in Southern Regional at Nsanje Community Centre ground on August 8, 2021.

The Leagues are restricted to Under 23 players because they are developmental and must be participated by players who have the potential to grow.

FAM President Walter Nyami-

landu Manda said the league will bridge the gap between elite football and lower levels and ensure systematic football structures at all levels across the country.

Nyamilandu Manda also added that the Districts Leagues will turn into a national championship by 2023 as leagues will be producing districts select sides to compete in the national championship.

At the time of reporting the Leagues were still in progress.



Women's Football drafts strategic plan

The National Women's Football Association (NWFA) in July 2021 drafted a first ever Women's football strategic plan, a blueprint that will shape the future of women's football in the country for the 2022-2025 period.

Football Association of Malawi (FAM) and NWFA organised a stakeholder meeting that drew representatives from coaches, referees, NWFA affiliates, the media, sponsors, former and current

players to solicit ideas on the future of the game.

The process is a follow up to Confederation of African Football (CAF) strategic plan which was launched last year. FAM has gone into partnership with UEFA who will assist to evaluate the document.

CAF plans to accelerate the growth of the women's game at all levels across Africa by facilitating more playing opportunities for women and girls and providing increased and improved training opportunities.

Kwimbira shines again

Malawi's celebrated assistant referees Bernadetta Kwimbira had another successful year after being named 2021 CAF's Best Women's Referee by the International Federation of Football History Statistics (IFFHS).

Kwimbira was one of the only two African female referees among the 16 that were nominated for the World Best Women Referee category alongside Rwandan Salima Mukansanga.

Kwimbira made history in January when she became the first ever

woman to officiate a match at CAF Men's Senior tournament.

Kwimbira achieved the feat on Tuesday January 21, when she joined a team of male referees as second assistant referees during Guinea's 3-0 win over Namibia in a Group D match at 2020 CAF 2020 African Nations Championship (CHAN) in Cameroun.

Four days later the Zomba-based referee made another history when she was part of the first ever all women refereeing team to officiate a match at a CAF Senior Men's tournament.

She, alongside Nigeria's Mimsen Lyorhe, were assistants to ex-

perienced Ethiopian referee Ldya Tafesse Adebele as they took charge of a Group D match between Namibia and Tanzania.

She also officiated at the 2020 Olympics Games in Tokyo, which were her second Olympics game after Rio 2016.

"I believe that my performance in the tournaments that I have officiated this year, which include the 2020 Chan, 2020 Tokyo Olympics and the inaugural CAF Women's Champions League played a big role in this award, and I will keep on raising the Malawian flag higher if appointed for other international assignments," said Kwimbira.

the country. We will continue to use them in our projects.

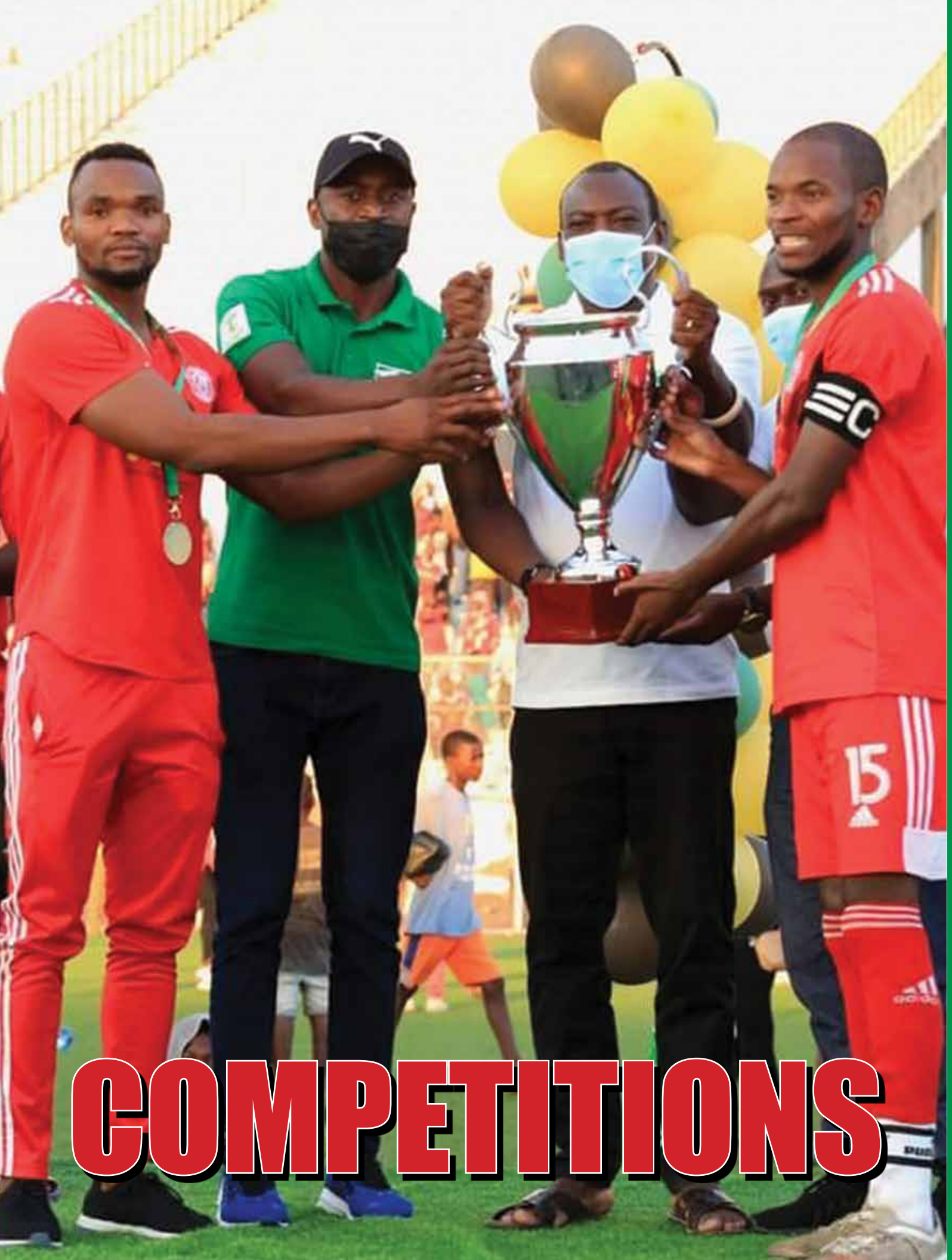
"For Lawrence, he is a legend. To me he is the best player the country has ever produced, and we thought of recognizing him while he is still alive," said Nyamilandu.

Mighty Wanderers striker Vincent Nyangulu finished the tournament with four goals to win the golden boot award.

FDH Bank Senior Marketing Manager Ronald Chimchere said the inaugural trophy was a success.



Bullets win first Airtel Top 8

Nyasa Big Bullets won their first Airtel Top 8 Cup after coming from behind to defeat two-time holders Silver Strikers 5-3 on post-match penalties in the final at Kamuzu Stadium in Blantyre on December 18, 2021.

This was the first final to be played in Blantyre since the competition started in 2017.

The two teams were tied 1-1 in regulation time and Bullets won through the lottery of shoot out after goalkeeper Ernest Kakhobwe

saved Levison Maganizo's spot-kick.

Stain Dave had put the bankers ahead in the 8th minute after connecting a Blessing Tembo cross with a header to beat Kakhobwe on the near post. Bullets levelled the score eight minutes later through Lanjesi Nkhoma.

Be Forward Wanderers forward Khumbo Ng'ambi won the award in 2017 with three goals while his teammate Joseph Kamwendo and Silvers strikers forward Khuda Muyaba only needed two goals each to claim the award in 2018 and 2019 respectively.



Bullets win third consecutive league title

Malawi National Football Team official sponsors FDH Bank on July 1 2021 doubled the team's sponsorship package from K60 million to K120 million annually for the next three years.

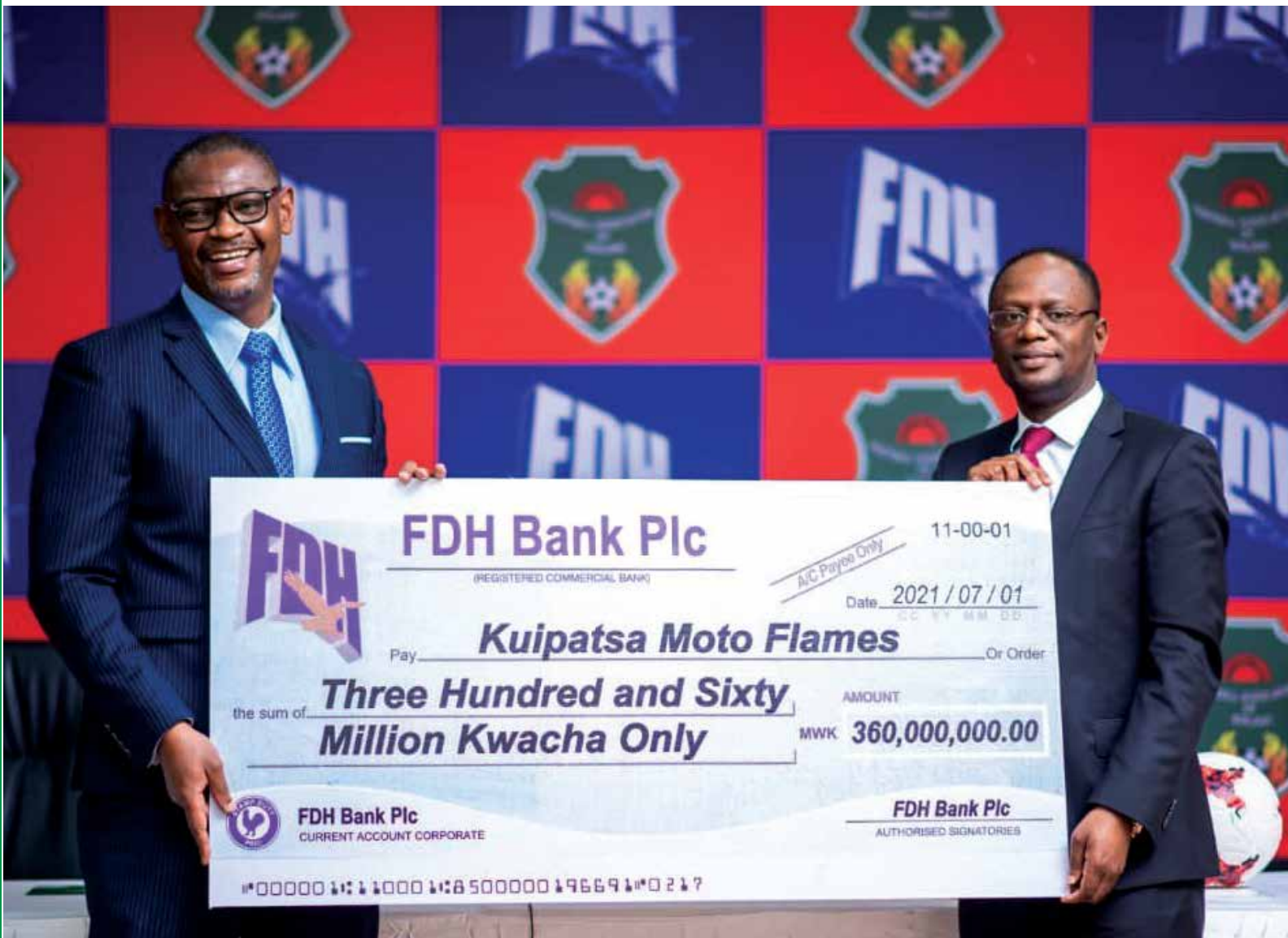
FFDH Bank Deputy Managing Director George Chitera said the Bank is happy to be part associated with the Flames who quali-

FAM PAYS TRIBUTE TO HORNER

FAM paid tribute to former Technical Director Manfred Hoener describing him as one of the outstanding pioneers of Malawi football with an exceptional eye for spotting talent.

Hoener died on March 6, 2021, due to heart failure at the age of 79.

FAM President Walter Nyamilandu Manda said the Malawi Football fraternity will always remember Hoener for his excellence in building youthful teams for the future.

"We had exciting and successful national youth teams during his time. Over and above that he worked very hard to expose talented players in Europe to give them a brighter future. If he had been around for long, Malawi football would have immensely benefitted from his expertise, and we would have been miles away.

"Personally, I will remember him for opening my doors to the national team when Rueben Malola was coach. He also offered me special training sessions with Chimwemwe Gadi when we were going for trials overseas. He did the same with all players who went for trials outside the country. He is probably one of the best expatriates we have had in terms of youth football technical development and may His Soul Rest in Peace," said Nyamilandu.

During his eight-year stay in Malawi, Hoener dedicated most of his efforts to youth development programmes, which he successfully executed.

His first notable achievement was when he guided the Malawi Under 18 National team to a Dana Cup title in Denmark and a third finish at the Gonithia Cup in Sweden during the team's European tour in 1997.

The same year he led the Malawi Under 20 National team to a bronze medal at the COSAFA Under-20 Youth Championship in Botswana.

In 1998, the same squad qualified for their maiden and to-date only appearance at the 1999 CAF AFCON Under-20 tournament that was held in Ghana.

Before he left in 2000, he led the foundation for the Under 17 national team that went on to win the COSAFA Under-17 Championship in 2001.

Former Flames captain Peter Mponda, who was part of the Dana Cup winning team and captained the Under-20 in Ghana, said Hoener played a big role in laying the foundation for the team that qualified for AFCON 2010.

"Most of the players who played in those 2010 qualifiers like me, Essau Kanyenda, Moses Chavula, Swadik Sanudi, Robert Ng'ambi, Jimmy Zakazaka, Fischer

Kondowe, Peter Mgangira, Allan Kamanga, Dan, and Clement Kafwafwa worked with Horner at Junior national teams as well as Junior Leagues between 1997 and 2000. He instilled that dream and mentality that made us develop into that formidable side. He demanded a lot on the pitch while outside he was a father figure," said Mponda.



INNOCENT BOTOMANI

Former FAM Executive Committee member and Super League of Malawi President Innocent Botomani died on July 18, 2021, at the Kamuzu Central Hospital.

Botomani, who served as SULOM President between 2011 and 2019, laid to rest on July 19, 2021 at Kondwani Village, TA Juma in Mulanje district.

FAM President Walter Nyamilandu described Botomani's death as a big blow to Malawi football.

RAPHAEL NASIMBA

Flames Chief supporter Raphael Nasimba died in the early hours of January 14, 2021. He was laid to rest on January 15 2021 in Zomba



LEONARD LENZO MALUNGA

Former Flames and Be Forward Wanderers midfielder Leonard 'Lenzo' Malunga died on January 19, 2021, at his home in Machinjiri, Blantyre after he just collapsed at his home and was pronounced dead on arrival at the hospital.

Malunga was a one club player after playing for Mighty Wanderers for more than a decade and made eight Flames appearances

Former Flames midfielder Jimmy Mkwanda on January 23, 2020. Mkwanda was part of the first national football team alongside retired Chief Justice Richard Banda battled stroke for six months and was diagnosed with Covid-19 on January 22.

ESTHER MWASE

Topic Academy FC player Esther Mwase succumbed to Malaria on Friday January 22, 2021, at Nkhata Bay District Hospital. Mwase played for Topic in the 2019 Northern Region Women's Football League

SEBASTIAN SHUMBA

Sebastian Tengani Shumba, a 16-year-old Referee in the FAM Under 16 League, who succumbed to Malaria on January 9.

MCGOVERN MPENI

Referee McGovern Mpeni a former FIFA Assistant died in Lilongwe in March.

He was at the time of his death a referees' assessors and FIFA Futuro Instructor Mpeni joined refereeing in 1990 as a beginner and rose through the ranks to become a FIFA Assistant Referee in 1999.

ALICE KANYOLI

Former National Women's Football Association general secretary Alice Kanyoli died on February 8. Kanyoli served as a general secretary for the Southern Region Women's Football Committee before being elected as a general secretary for the National Women's Football Association where she served for two terms from 2004 to 2012.

TOPSY MSUKU

Former Bata Bullets and Flames striker Topsy Msuku one of outstanding football talents of the post-independence Malawi died on July 20, 2021, in South Africa at the age of 61.

He was part of the invincible Bullets that swept every silverware on offer in 1975. He was part of the Flames squad that went on to win the first international silverware when we lifted the 1978 CECAFA Championship. He also helped mentor upcoming players for both Bullets and Flames.

Msuku played 24 times for the Flames with 19 starts and five substitute appearances and scored three goals between 1975 and 1978.

He made his debut in a friendly match against Mauritius on 29 January 1975 as Flames won 1-0 courtesy of a Zoro Msiska's lone strike.

He scored his first goal on 28th February 1976 when he claimed a brace in Flames' 4-1 win over Lesotho in a friendly match in Blantyre.



DAVE NG'AMBI

Dave Ng'ambi a former Under-23 international Dave Ng'ambi who died in a road accident on December 4. Ng'ambi played for Civil Service United from 2008 until the 2014/2015 season when he moved for Nyasa Big Bullets FC. He later joined Mzuni in 2018 season.

HASSAM JUSSAB

Former Nyasa Big Bullets chairperson Hassam Jussab died on December 30, 2021, at Blantyre Adventist Hospital after an illness.

Jussab, 58, as one of the best club administrators, who is remembered for winning five successive Super League titles during his tenure from 2000 to 2004. He was also at the helm when the People's Team reached the quarter finals of the CAF Champions League in 2004.

To enable the Executive Committee to meet these responsibilities, the Executive Committee sets standards for internal control aimed at reducing the risk of error or loss in a cost effective manner. The standards include the proper delegation of responsibilities within a clearly defined framework, effective accounting procedures and adequate segregation of duties to ensure an acceptable level of risk. These controls are monitored throughout the Association and all employees are required to maintain the highest ethical standards in ensuring the association's business is conducted in a manner that in all reasonable circumstances is above reproach. The focus of risk management in the Association is on identifying, assessing, managing and monitoring all known forms of risk across the Association. While operating risk cannot be fully eliminated, the Association endeavours to minimise it by ensuring that appropriate infrastructure, controls, systems and ethical behaviour are applied and managed within predetermined procedures and constraints.



Independent Auditor's Report

To the members of Football Association of Malawi

Opinion

We have audited the financial statements of Football Association of Malawi, which comprise the statement of financial position as at 31 December, 2021, and the statement of profit or loss and other comprehensive income, statement of changes in funds and statement of cash flows for the year then ended, and a summary of significant accounting policies and other explanatory notes.

In our opinion, the financial statements give a true and fair view of the financial position of Football Association of Malawi as of 31 December, 2021 and of its financial performance and its cash flows for the year then ended in accordance with the provisions of the Association's Constitution and in conformity with International Financial Reporting Standards.

Basis for Opinion



Accounting Policies

1. Presentation of financial statements

The financial statements have been prepared in accordance with International Financial Reporting Standards. The financial statements have been prepared on the historical cost basis, except for equity investments at fair value, and incorporate the principal accounting policies set out below. They are presented in Malawi Kwacha.

1.1 Significant judgements and sources of estimation uncertainty

In preparing the financial statements, management is required to make estimates and assumptions that affect the amounts represented in the financial statements and related disclosures. Use of available information and the application of judgement is inherent in the formation of estimates. Actual results in the future could differ from these estimates which may be material to the financial statements.

Trade receivables, Held to maturity investments and Loans and receivables

The association assesses its trade receivables, held to maturity investments and loans and receivables for impairment at the end of each reporting period. In determining whether an impairment loss should be recorded in profit or loss, the company makes judgements as to whether there is observable data indicating a measurable decrease in the estimated future cash flows from a financial asset.

The impairment for trade receivables, held to maturity investments and loans and receivables is calculated on a portfolio basis, based on historical loss ratios, adjusted for national and industry-specific economic conditions and other indicators present at the reporting date that correlate with defaults on the portfolio. These annual loss ratios are applied to loan balances in the portfolio and scaled to the estimated loss emergence period.

Fair value estimation

The fair value of financial instruments traded in active markets (such as trading and available-for-sale securities) is based on quoted market prices at the end of the reporting period. The quoted market price used for financial assets held by the association is the current bid price.

The fair value of financial instruments that are not traded in an active market (for example, over the counter derivatives) is determined by using valuation techniques. The association uses a variety of methods and makes assumptions that are based on market conditions existing at the end of each reporting period. Quoted market prices or dealer quotes for similar instruments are used for long-term debt. Other techniques, such as estimated discounted cash flows, are used to determine fair value for the remaining financial instruments. The fair value of interest rate swaps is calculated as the present value of the estimated future cash flows. The fair value of forward foreign exchange contracts is determined using quoted forward exchange rates at the end of the reporting period.

The carrying value less impairment provision of trade receivables and payables are assumed to approximate their fair values. The fair value of financial liabilities for disclosure purposes is estimated by discounting the future contractual cash flows at the current market interest rate that is available to the association for similar financial instruments.

Provisions

Provisions were raised and management determined an estimate based on the information available.

1.2 Property and equipment

The cost of an item of property and equipment is recognised as an asset when:

- it is probable that future economic benefits associated with the item will flow to the Association; and
- the cost of the item can be measured reliably.

Property and equipment is initially measured at cost.

1.2 Property and equipment (continued)

Costs include costs incurred initially to acquire or construct an item of property and equipment and costs incurred subsequently to add to, replace part of, or service it. If a replacement cost is recognised in the carrying amount of an item of property and equipment, the carrying amount of the replaced part is derecognised.

The revaluation surplus in equity related to a specific item of property and equipment is transferred directly to retained earnings when the asset is derecognised.

Property, plant and equipment are depreciated on the straight line basis over their expected useful lives to their estimated residual value.

Property and equipment is carried at cost less accumulated depreciation and any impairment losses.

The useful lives of items of property and equipment have been assessed as follows:

Item	Average useful life
Buildings	50 years
Furniture and fixtures	5 years
Motor vehicles	4 years
Office equipment	4 years

The residual value, useful life and depreciation method of each asset are reviewed at the end of each reporting period. If the expectations differ from previous estimates, the change is accounted for as a change in accounting estimate.

The depreciation charge for each period is recognised in profit or loss unless it is included in the carrying amount of another asset.

1.3 Intangible assets

An intangible asset is recognised when:

- it is probable that the expected future economic benefits that are attributable to the asset will flow to the association; and
- the cost of the asset can be measured reliably.

Intangible assets are initially recognised at cost.

Cost is determined as the amount paid for the asset by the Association or fair value of the asset received from the donor.

Amortisation is recognised together with depreciation in the statement of profit or loss.

The assets are amortised on a straight line basis at rates calculated to write off the cost of each intangible assets, over its expected useful life as follows:

Other financial assets are measured at fair value with changes in fair value recognised in statement of profit or loss.

Trade and other receivables

Trade receivables are measured at initial recognition at fair value, and are subsequently measured at amortised cost using the effective interest rate method.

Trade and other payables

Trade payables are initially measured at fair value, and are subsequently measured at amortised cost, using the effective interest rate method.

Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and demand deposits, and other short-term highly liquid investments that are readily convertible to a known amount of cash and are subject to an insignificant risk of changes in value. These are initially and subsequently recorded at fair value.

1.5 Inventories

Inventories are measured at the lower of cost and net realisable value on the first-in-first-out basis.

1.6 Impairment of assets

The Association assesses at each end of the reporting period whether there is any indication that an asset may be impaired. If any such indication exists, the Association estimates the recoverable amount of the asset.

If there is any indication that an asset may be impaired, the recoverable amount is estimated for the individual asset. If it is not possible to estimate the recoverable amount of the individual asset, the recoverable amount of the cash-generating unit to which the asset belongs is determined.

The recoverable amount of an asset or a cash-generating unit is the higher of its fair value less costs to sell and its value in use.

If the recoverable amount of an asset is less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. That reduction is an impairment loss.

An impairment loss of assets carried at cost less any accumulated depreciation or amortisation is recognised immediately in profit or loss. Any impairment loss of a revalued asset is treated as a revaluation decrease.

1.7 Provisions and contingencies

Provisions are recognised when:

- the Association has a present obligation as a result of a past event;
- it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation; and
- a reliable estimate can be made of the obligation.

The amount of a provision is the present value of the expenditure expected to be required to settle the obligation.

Contingent assets and contingent liabilities are not recognised. Contingencies are disclosed in note .

1.8 Grants

Grants are recognised when there is reasonable assurance that:

- the Association will comply with the conditions attaching to them; and
- the grants will be received.

Grants are recognised as income over the periods necessary to match them with the related costs that they are intended to compensate.

A grant that becomes receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the entity with no future related costs is recognised as income of the period in which it becomes receivable.

Grants related to assets, including non-monetary grants at fair value, are presented in the statement of financial position as Capital Fund.

1.9 Revenue

- Revenue represents share of gate takings, donations net of direct expenditure and miscellaneous income received in the year.
- Dividend income is recognized in the financial statements when they are declared and the Association has rights to receive.
- Share of gate takings is recognised on cash basis, on a predetermined sharing pattern of the net proceeds from gate collections.

1.10 Finance income and expenses

Finance income comprises interest income on funds invested and foreign currency gains. Interest income is recognized in the statement of comprehensive income as it accrues, taking into account the effective yield on the asset.

Finance expenses comprise interest expense on borrowings, foreign currency losses, changes in the fair value of financial assets at fair value through profit or loss, impairment loss recognized on financial assets. All borrowing costs are recognized in profit or loss using the effective interest method.

1.11 Translation of foreign currencies

Foreign currency transactions

A foreign currency transaction is recorded, on initial recognition in Malawi Kwacha, by applying to the foreign currency amount the spot exchange rate between the functional currency and the foreign currency at the date of the transaction.

At the end of the reporting period:

- foreign currency monetary items are translated using the closing rate.

Exchange differences arising on the settlement of monetary items or on translating monetary items at rates different from those at which they were translated on initial recognition during the period or in previous financial statements are recognised in profit or loss in the period in which they arise.

Cash flows arising from transactions in a foreign currency are recorded in Malawi Kwacha by applying to the foreign currency amount the exchange rate between the Malawi Kwacha and the foreign currency at the date of the cash flow.

1.12 New and amended standards adopted by the Association

The following amendments became effective as at 1 January 2021:

- *Interest Rate Benchmark Reform – Phase 2 – Amendments to IFRS 9, IAS 39, IFRS 7, IFRS 4 and IFRS 16*

The amendments provide temporary reliefs which address the financial reporting effects when an interbank offered rate (IBOR) is replaced with an alternative nearly risk-free interest rate (RFR).

- *Covid-19-Related Rent Concessions beyond 30 June 2021 (Amendment to IFRS 16)*

The amendment provides lessees with an exemption from assessing whether a COVID-19-related rent concession is a lease modification
